**SUBJECT: REPORT OF INVESTIGATION INTO LISTS OF PERSONS ALLEDGED TO HAVE SIGNED THE PETITION OBJECTING THE RSPO CERTIFICATION OF SOCFIN, SIERRA LEONE SENT BY MALOA.**

I refer to the above and state that investigations carried out by my Chiefdom Authorities into lists of persons alleged to have signed the petition objecting to the RSPO Certification of Socfin was found to be fraudulent. 95% of people in 34 villages on the petition list did not sign by themselves; somebody signed on the behalf. Few MALOA members, working in collaboration with some International NGOs carried out this criminal act. The few who signed were given wrong and misleading information. In fact, two of the villages mentioned on that petition list (Jao and Nyandehun) are not Socfin's operational villages. This is forgery, and act of criminal behavior at the highest level. How on earth can four years old child sign a petition as it was the case in Kpanguma Village. These criminals will be prosecuted; one has already been prosecuted at the Malen Native Court and has pleaded guilty. Please see attached.
