## PPRC PRESS RELEASE – 25<sup>th</sup> August, 2020

The Political Parties Registration Commission ("hereinafter called **"the PPRC"**") notes with grave concern, the incessant inflammatory hate speeches and now treasonable utterances of some Malcontents, most of whom are resident in the Diaspora.

They have persistently hauled unprintable invectives at the First Family and other Senior Citizens and incited violence and hate in the country. Their latest tirade being, a call for the violent deposition of a democratically elected Government, by Unlawful means.

These incendiary speeches and inciteful statements, have led to repeated breaches of the public peace, with resultant unfortunate loss of young lives and wanton destruction of both public and private properties.

The PPRC therefore calls on the leadership of all Registered Political Parties, to go beyond distancing themselves from the utterances of these miscreants and further publicly condemn and denounce the unsavoury existential threats to peace and stability of the Nation, posed by their profane and intemperate statements. Anything short of this, gives the semblance of indifference to their proscribed conduct, in the eyes of our gullible Youths and emboldens and spurs them on, in their unpatriotic crusade.

In the interim, the PPRC will immediately constitute an Investigative Committee, to ascertain whether or not these Messengers of hate speeches, have any connection or link with any of the Registered Political Parties.

We therefore entreat all Political Parties, SLP, NEC, ONS and other line institutions, to lend their support to this Committee in the cause of their investigation.
