It is obvious that anyone abused position of trust must face the law and this includes serving government officials, but this government has been incompetent, indecisive with no clearly defined policy in the fight against corruption. Focusing on the past government officials, to discredit your political opponent whiles your government is not above suspicion on corruption practices will not be tolerated henceforth.
