#### PRESS STATEMENT

DECLARATION OF RESULTS FOR PARLIAMENTARY RE-RUN ELECTION HELD IN CONSTITUENCY 110, WESTERN AREA RURAL DISTRICT AND PARLIAMENTARY BYE-ELECTION HELD IN CONSTITUENCY 078, BO DISTRICT, ON SATURDAY 12<sup>TH</sup> DECEMBER, 2020

- 1. By the powers vested in it under Section 33 of the Constitution of Sierra Leone, 1991 (Act No.6 of 1991), and pursuant to the provisions of Section 39(1) of the said Constitution, Sections 69 (1) and 70 (1) of the Public Elections Act, 2012 (Act No 4 of 2012), a re-run Parliamentary and bye elections were successfully conducted by the National Electoral Commission (NEC) in Constituency 110, Western Area Rural District and Constituency 078, Bo District, on the 12<sup>th</sup> Day of December, 2020 in accordance with the relevant electoral legal framework.
- 2. The vacancy in Constituency 110 occurred as a result of a judgment passed on the 31<sup>st</sup> day of May 2019, in the High Court which ordered inter-alia, that the Parliamentary election conducted on the 7<sup>th</sup> March 2018 in Constituency 110 in the Western Area Rural District be declared null and void.
- The vacancy in Constituency 078 occurred as a result of the death of Hon. Alimamy Osman Kamara (RIP), Member of Parliament of the Sierra Leone Peoples Party (SLPP), representing Constituency 078, Bo District.
- 4. For Constituency 110 re-run polls, two (2) Political Parties, contested the Parliamentary Re-run Election as follows: The All Peoples Congress (APC), and the Sierra Leone Peoples Party (SLPP).
- 5. For the Parliamentary bye-election Two (2) Political Parties contested the bye-election as follows: The All Peoples Congress (APC) and the Sierra Leone Peoples Party (SLPP).
- 6. The Sierra Leone Police (SLP) provided security in all the polling centres in both constituencies.

7. Political Party agents, the Political Parties Registration Commission (PPRC), the office of National Security (ONS), the National Election Watch (NEW), the Election Conflict Prevention and Mediation Group, Media Houses and a host of other civil society groups observed the elections in both constituencies and the tallying of results at both NEC District Offices in Bo and Waterloo.

Analysis of the Results: Constituency 110, Western Area Rural District:

- Twenty-One (21) polling centres results were entered into the result data base, representing 100% of all polling centres in the Constituency.
- The voter turnout was 18,740 out of a voter register of 42,941; giving a percentage turnout of 43.64 %;
- The total number of valid votes cast was 18,083;
- There were 657 invalid votes, representing 3.51% of total votes cast.

Therefore, in exercise of the powers conferred on me as the National Returning Officer, by Section 94 Subsection (4) of the Public Elections Act 2012 (Act No. 4 of 2012), I hereby declare **KADIJATU DAVIES** of the **APC**, who having polled the higher number of valid votes cast, duly elected Member of Parliament for Constituency 110 in the Western Area Rural District.

### Analysis of the Results: Constituency 078, Bo District:

- Twenty-Seven (27) polling centres results were entered into the result database, representing 100% of all polling centres in the Constituency.
- The voter turnout was 10,438 out of a voter register of 22,121; giving a percentage turnout of 47.19 %
- The total number of valid votes cast was 10,105
- There were 333 in valid votes, representing 3.19% of total votes cast.
