Count 6: Possessing property knowing the same to be the proceeds of corruption contrary to Section 52(1)(c) of the Anti-Corruption Act No. 12 of 2008 as amended by Anti-Corruption (Amendment) Act No. 9 of 2019;

Count 7: Conspiracy to commit a corruption offense contrary to Section 128 of the ACC Act No. 12 of 2008 as amended by Section 14 of ACC (Amendment) Act No. 9 of 2019;

Count 8: Misappropriation of public property contrary to Section 36(1) of the Anti-Corruption Act No. 12 as amended by Section 1 of the Anti-Corruption (Amendment) Act No. 9 of 2019;

Count 9: Conspiracy to commit a corruption offense, contrary to Section 128 of the Anti-Corruption Act No. 12 of 2008 as amended by Section 14 of the Anti-Corruption (Amendment) Act No. 9 of 2019;

Count 10: Abuse of office contrary to Section 42(1) of the Anti-Corruption Act No. 12 of 2008 as amended by the Anti-Corruption (Amendment) Act No. 9 of 2019;
