As it is stated in sec 39. (1) When the seat of any Member of Parliament becomes

(2) The Proclamation

appointing a date for the holding of an election to fill a vacancy shall be published in the Gazette not less than twenty-one days before the date appointed for holding the election.

Sir, it is also stipulated in Sec 77 (f), A Member of Parliament shall vacate his seat in Parliament, if in the case of such a Member as is referred to in paragraph (b) of subsection (1) of section 74, he becomes a Paramount Chief under any law; or

Mr. Chief Electoral Commissioner, you will agree with me that the actions of your staff have attendant consequences on your hard worn reputation and the National Electoral Commission (NEC)), FoSLYN advises that you do the following to clean and maintain your reputation by doing the following:

- To avoid future occurrences in subsequent elections we suggest that you don't allow high profile politicians who have the penchant to steer insecurity in polling stations.
- Ensure that all staff (both core and support staff) attached to NEC remain independent and impartial and maintain high standards of professionalism in their conduct towards the electoral process of the country.
- Election result(s) that are validated by all parties involved in observing and monitoring elections are protected and kept under safe custody
- Prevent electoral malpractices that will question the credibility of NEC and the entire electoral management system in the country.
- We call on the Sierra Leone Police to without delays charge to Court the NEC staff caught on the height as we are prepared to monitor the proceedings at the High Court and give updates to the public.
- Without delays give us/the public a date for the Constituency 057, Sambaia Bendugu, Tonkolili Bye-Election.
