

Executive Summary

2021 was exciting! Not only did we launch our Strategic Plan 2020-2024, but we also held a successful Get Involved! Walk with GBV Survivors Sponsored Walk during the 16 Days of Activism campaign against Gender-Based Violence to raise awareness about sexual violence and abuse in Sierra Leone.

We also honoured the contributions of three of our long-serving and dedicated Board Members who marked the end of their tenure with the board and welcomed new members to our Board of Directors.

More excitingly for us, more survivors of SGBV access justice and perpetrators were held to account for their actions including a 35-year-old teacher being sentenced to three years in prison for sexually penetrating his 17-year-old pupil.

From the data we're presenting, we observed that there has been deceased in reported cases to the Rainbo Centres, however, this does not in any way suggest that there is a change in behaviour of the people.

Meanwhile, we attribute this to the following factors:

- ♣ People are now aware of sexual abuse and violence in communities due to the ongoing awareness-raising in these communities by various partners including the media, CSOs and government
- ♣ The introduction of the Sexual Offences Model court that contributed to speedy trials of Sexual penetration cases resulted in a change.
- Some survivors are now confident and willing to share their stories in public.
- ♣ There has also been increased access to support services for survivors of SGBV across the country.

In conclusion, we observed that

- ♣ Perpetrators are committing dreadful crimes including the killing of their survivors because of a life sentence
- ♣ Perpetrators are getting younger example 7 years old boy sexually abused a 3-year-old baby girl and repeated the same when he is 12 years to a 5-year girl.
- ♣ There are no reformation programmes that focus on perpetrators while in prison or out in communities.
- → Significant rise in anxiety level among survivors resulting to mental health conditions. There is a need for mental health interventions for survivors of SGBV
- ♣ Women and girls who experience one form of assault are more likely to experience other forms of gender-based violence as was noted in the dual assault against a survivor who was beating, her pants torn and the perpetrator inserting his fingers into the survivor's vagina.
- ♣ Physical violence against women and children increased exponentially during the Covid 19 period.
- ♣ Over the past couple of years, there has been a significant focus on SGBV in Sierra Leone with the government making it a priority to reduce it. However, we observed that 75% of the SGBV cases reported to Rainbo is child sexual abuse with less adult reporting.

There are various reasons for this including the stigma associated with adults reporting sexual abuse to report the police or service providers. The data suggests that there is a substantial problem about child sexual abuse (CSA) and the risk of conflicting SGBV and CSA to the detriment of both adult and child survivors.

We believe that through the collective efforts of government, civil society organisations, the media and the business sector working together, we can broaden the impact of the campaign to tackle a wide range of issues affecting women and girls in Sierra Leone including sexual violence/rape, early marriage, teenage pregnancy, health, education etc. The high-level committee of the Government and spotlight on these issues has given us confidence and inspired us as an organisation to overcome some of the long outstanding barriers in the fight against SGBV in Sierra Leone. This has created a demand for our services and reassured survivors to report sexual abuses cases to FSU and other service providers.

We would like to thank our partners and donors including the Government of Sierra Leone, Irish Aid, European Union Delegation to Sierra Leone, Comic Relief, Trocaire and UNFPA for their financial support to Rainbo. Rainbo Initiative is committed to continuing working with survivors in 2022 and to expanding our services to two new districts.








Youngest & Oldest survivors of Sexual and Physical assaults

From 2020 to 2021:

- The scale of sexual assault has decreased by 7.2%
- The scale of physical assault in the communities has increased by 56.0%
- Referrals of survivors by the FSU decreased by 7.2%
- Referrals of survivors by community people decreased by 2.7%
- Rainbo referrals of survivor cases to other Service Providers increased by 208.8%
- Survivor cases submitted to High Court increased by 44.7%
- Successful prosecution of survivor cases decreased by 69.9%
- Pregnancies among survivors decreased by 3.9%
- The number of **female survivors** decreased by **7.3%** while **male survivors** increased by 15%.

Dual assault case (Both physical and sexual)

Between these two years, we saw 1 case of both physical and sexual assault in which case, the perpetrator physically beat the woman, tore her pants and inserted his fingers (digital penetration) into the woman's vagina while community people watched although he was later arrested and case charged to court.

On the academic status of survivors within these two years 2020 to 2021

We saw:

- 26.0% decrease in survivors who were at Kindergarten/Nursery stage in school
- 13.8% decrease in survivors who were at Primary school stage at school
- 18.0% decrease in the number of survivors at JSS
- 19.7% increase in survivors at Senior Secondary School stage
- 27.6% increase in survivors attending University/Vocational institutions
- 1 Teacher survivor
- 1,100.0% increase in the number of survivors who are Homeworkers
- 183.3% increase in survivors who are Housewives

16.8% decrease in the number of gang assaults against survivors of sexual assault

25.0% decrease in the number of unknown perpetrators of sexual assault

Note:

- We saw an overall decrease in the time of sexual assault from 2020 to 2021.
- According to the table above, most of the sexual assault happens in the evening followed closely by afternoon time
- The more sexual assault happened in 2020 than in 2021.

- In 2021, sexual assault cases are the highest in **May** with a **20.8%** increase in the cases from 2020 to 2021.
- In 2020, the highest sexual assault cases were in Sept and November.
- It was only in **April and May** that we noted a **% increase of 15.9% and 20.8%** respectively between 2020 and 2021. In **all other 10 months** for both 2020 and 2021, there was a **% decrease** in sexual assault cases.
- For both years the highest % decrease was in August with 26.4%.
