THE POSITION OF DOMINION CHRISTIAN UNIVERSITY (DCU-SL) ON THE PRESS RELEASE FROM TERTIARY EDUCATION COMMISSION (TEC) DATED 1ST APRIL, 2022.

Responding to the unfolding allegations and publications released by the Tertiary Education Commission (TEC) going viral on the social media concerning the credibility, legality and national recognition of Dominion Christian University (DCU-SL), in order to disdain both our National and International recognition and credibility to the populace, on that premise, we the Senior Administrative Board (SAB) of the aforementioned Christian institution hereby ascertain with zest, our verifiable legal identities that give us both National and International credence to confer recognition on reputable persons in society.

On that proximity, we are calling on the attention of **the International Community**, media houses, the Director of Compliance, Corporate Affairs Commission and the general public to the fact that Dominion Christian University (DCU) is legally recognized based upon the following national and international credentials that;

1. We are incorporated under the laws of Sierra Leone and registered at Corporate Affairs Commission (CAC) Sierra Leone, with Registration Certificate #: **SL131221DOMIN13026**
2. We are also registered with the Western Area Rural District Council, for recognition wherein the university has her Administrative Secretariat, with Registration Certificate #: **WC0010843/21**
3. We are also tax compliance and have registered with the National Revenue Authority (NRA) Sierra Leone, with Registration Certificate or (TIN) #: **TIN1000240207**
4. We are as well internationally accredited by the International Accreditation Commission For Education, USA, with Certificate of Accreditation #: **IACE-00122/2018.**

To this effect, we hereby debunk the statements quoting paragraph one, line two and paragraph two line eight of the TEC Press Release stating that **“the so called Dominion Christian University is illegal and not accredited”**. Our stance on this is that, Nationally we are legally registered and recognized, while accredited internationally, even as our process with TEC is on going, of which they are knowledgeable. In addendum, we have records to the effect from TEC, of which TEC should not act in oblivion. On that note, we want to assure the public of our compliance with TEC, regardless of our Program.
